A second regular monthly meeting will be held at 6:30 p.m. on January 29, February 26, March 26, April 23, May 28, June 25, July 23, August 27, September 24, October 22, November 19, and December 17, 2026 AS NEEDED.

The Paupack Township Planning Commission will hold their regular monthly meetings at 6:30 p.m. on January 8, February 5, March 5, April 2, May 7, June 4, July 2, August 6, September 3, October 1, November 5, and December 3, 2026 AS NEEDED. Workshops start at 5:30 p.m. before Planning Commission scheduled meetings. Proposed subdivisions must be submitted to the Township Secretary at least ten (10) business days prior to the Planning Commission Meeting.

All meetings will be held at the Paupack Township Municipal Building, 25 Daniels Road, Lakeville, PA.

As per requirements of the "Pennsylvania Second Class Township Code" Section 917 Appointment of Accountant paragraph (b) subsection (1) and (2): the Paupack Township Supervisors intend to appoint a certified or competent public accountant to audit the fiscal affairs of the Township of the year ending December 31, 2025. The appointment will be made by Resolution at the annual reorganization meeting of the Township to be held on Monday, January 5th, 2026.
